### PLEASE GIVE SPECIAL ATTENTION TO THE FOLLOWING:

(IN ADDITION: GIVE PROPERTY IDENTIFICATION NUMBER FOR ALL PROPERTY LISTED)

- AUTOMOBILE:** Give trade name, year, model and number of cylinders. Example: "Ford 1980 Fairmont, 6 cyl., 2 door H.T."
- MOTORCYCLES-TRAIL BIKES:** Give trade name, year and model. Example: "Harley-Davidson 1969, M65, Sport"; "Honda 1973, CB350F".
- TRUCKS:** Please do not list merely as "pickup". Give full information. Example: "Chevrolet 1979, C20, Fleetside PU", "Ford 1979, F-250, styleside PU". "Ford 1970, F-500 Platform".
- TRAVEL TRAILERS AND CAMPERS:** Give name of manufacturer, year, model, length, width and specify whether travel trailer, tent or camper trailer, or pickup camper.
- BOATS:** Give name, model, year, length and whether inboard, inboard-outdrive or Outboard. If outboard, list motor separately, giving full description.
- BOAT TRAILERS:** Year, make and model.
- MOBILE HOMES:** Give name and manufacturer, year, model, length and width.
- MACHINERY AND TOOLS:** (Manufacturer, Processor or reprocessor); Please submit total capitalized cost for each year.
