Separate sealed bids, from Contractors for construction of the Stormwater and Erosion and Sediment Control portions of the Patriot Centre at Beaver Creek, Phase III Project will be received by Henry County, Virginia at Room 210, Purchasing Department of the Henry County Administration Building in Collinsville, Virginia until 3:00 p.m. local time on April 17, 2014 and then publicly opened and read in the 1<sup>st</sup> Floor Main Board Room.

The project consists of the installation and maintenance of stormwater and erosion and sediment control measures required for the construction of the roadbed for the eastbound lanes of Beaver Creek Drive from Lot 10 to Barrows Mill Road and Lot 11, a 15 acre industrial building pad. Grading of the road bed and Lot 11 will be performed by construction divisions of the Virginia National Guard. The stormwater and erosion and sediment control Contractor shall coordinate with Henry County and the Virginia National Guard during the course of the project to make adjustments and maintain the stormwater and erosion and sediment control measures as the Virginia National Guard performs grading.
