Sealed bids are invited for the construction of the new Meadow View Elementary School for Henry County Public Schools in accordance with drawings and specifications prepared by RRMM Architects, PC. The project is generally described as the construction of a new +/- 95,000 square foot elementary school on two floors and all related sitework at 740 Figsboro Road, Martinsville, Virginia.

A mandatory Pre-Bid Conference will be held on March 15, 2016, at 2:00 PM in the First Floor Board Room of the Henry County Administration Building at 3300 Kings Mountain Road in Martinsville, Virginia 24112. Bids will only be accepted from bidders in attendance and registered on the sign-in sheet. The latest date for receipt by the Architect of bidders' questions to be answered prior to receipt of bids will be Close of Business on March 21, 2016.

Procedures for submitting a bid, claiming an error, withdrawing of bids and other pertinent information are contained in the Instructions to Bidders, which is part of the Invitation for Bids. The Owner reserves the right to reject any and all bids and/or to waive any informality in the bidding procedures.

Sealed bids in duplicate will be received to the attention of Carole Jones at the Henry County Administration Building, Purchasing Department, Room 210, P.O. Box 7 (Postal), 3300 Kings Mountain Road (UPS & FedEx), Martinsville, Virginia 24078. The deadline for submitting bids is 3:30 PM local standard time on Tuesday, March 29, 2016. The bids will be opened publicly and read aloud shortly thereafter at the same location. Include Bid #16-032933-2974 on the outside of the envelope.

A Bid Bond and Contract Security will be required of all bidders regardless of amount. Bidders shall be required to bind their bid for 30 days. The contract for the project shall be awarded on a lump sum basis of the Base Bid plus such Alternates as the Owner in its sole discretion decides to award. Bidder's attention is directed to the requirements of Title 54, Chapter 11, of the Code of Virginia pertaining to registration of Contractors.
