6. BASIS FOR REJECTIONS AND AWARD:

THE COUNTY OF HENRY RESERVES THE RIGHT TO ACCEPT OR REJECT ALL BIDS OR PARTS OF BIDS, TO WAIVE INFORMALITIES AND TECHNICALITIES, AND TO REQUEST REBIDS. THE BILL ALSO PROVIDES THAT THE REQUIREMENT BE WAIVED IN EMERGENCY SITUATIONS WHEN IT IS REASONABLY ANTICIPATED THAT THE CONTRACTOR OR HIS EMPLOYEES WILL HAVE NO DIRECT CONTACT WITH STUDENTS.

1. All instructional supplies in the BID, quoted on by vendors, must meet the following criteria:
 - a. Non-Toxic: Both Federal and Commonwealth of Virginia Laws require that all instructional supplies used in certain grade levels of schools must comply with ASTM D-4236 and be properly labeled in accordance with this standard.
 - b. All products provided by vendor shall bear CP, AP, and HL (non-toxic) seals. Vendor must show written evidence of compliance with safety standard **ASTM D-4236** if AP or CP seal is not present on item or product packaging.
 - c. Vendor must state that his products have been properly tested and do comply with ASTM D-4236.
