#### **PLEASE READ PRIOR TO SUBMITTING FORM**

- Out-of-area state licensed contractors performing work in the County must obtain a Henry County business license prior to beginning work unless calendar year gross receipts are expected to be below \$25,000. We offer Reciprocity up to but not including \$25,000. Please reference the Reciprocity application for more information.
- If you are operating a Corporation, LLC or similar entity in Virginia, it must be registered with the Virginia State Corporation Commission. Additionally, if you are using an assumed name, DBA ("doing business as") or T/A ("trading as") business name, a Certificate of Assumed or Fictitious Name must be filed with the State Corporation Commission. Copies of these documents must be submitted at the time of application.
- You will need to provide a copy of your Virginia Class A, B, or C Contractor License or Tradesman certification.
- You will need to provide a copy of your Acknowledgment of Compliance from the Virginia Workers Compensation Commission Insurance Department (61-A Form). Do not send copies of insurance certificates.
- Once a business has a license in Henry County, it must be renewed each year on or before March 1<sup>st</sup>, or the account closed in writing. Non-filers are subject to administrative assessments.
- No business license shall be renewed until the applicant has paid all delinquent business license and personal property taxes owed by the business to Henry County.
- If any piece of your entity changes (i.e. name, address, phone, email, ownership, etc.) you must notify the Commissioner of Revenue's Office to keep record accurate, update new fictitious name with State Corporation Commission, if applicable, and contact DPOR, if applicable, within 30 days of your changes. These changes would also include:
  - **Closure of business in Henry County.** Failure to notify the Commissioner of Revenue's office of a closure or business has moved out of Henry County will result in unsolicited statutory assessments, penalties, and interest until notification is received.
  - **Business/trade has moved location within Henry County.** In addition to notifying the Commissioner of Revenue's Office, a new Zoning approval would be required.
- The business license tax is based on gross receipts of the business and is assessed at the following rate only if gross receipts are above \$100,000:
  - Contractor: .00025 of Gross Receipts
- **NOTE: The minimum fee for the issuance of a business license is \$30.00**
